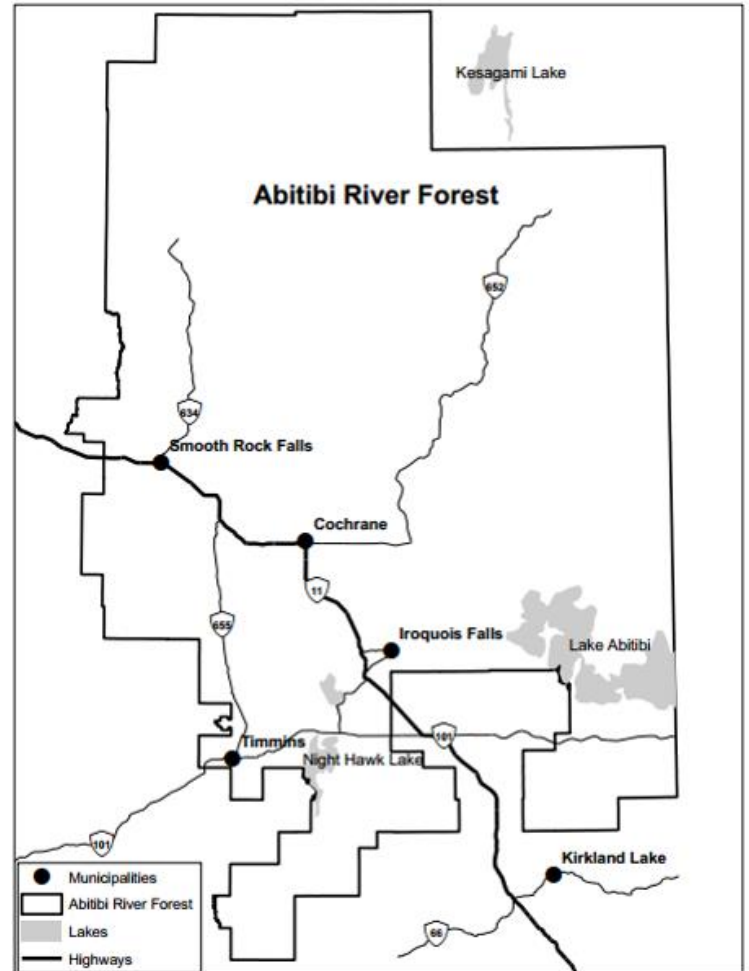
The audit covers the **April 1, 2010 to March 31, 2017** operating period.

Purpose of the Independent Forest Audit

The Purpose of the audit is to assess:

- compliance with the *Crown Forest Sustainability Act*,
- compliance with the Forest Management Planning Process,
- a comparison of planned versus actual forest management activities,
- the effectiveness of forest management activities in achieving audit criteria and management objectives,
- the effectiveness of previous audit action plans, and
- a licensee's compliance with the terms and conditions of the Sustainable Forest Licence.

The six-member audit team will evaluate forest management practices such as **forest management planning, harvest operations, forest renewal activities, road construction and maintenance as well as opportunities for public input and Aboriginal community consultation**. The main objectives of the audit are to assess compliance with provincial laws and regulations as well as comment on the effectiveness and sustainability of forestry activities on the management unit.

In addition, the independent forest audit provides an opportunity to improve Crown land management in Ontario through adaptive management. The audits are conducted by consultants that are independent of the Ministry of Natural Resources and Forestry, and the audited forest licence holders.
